- ❑ *EB-5 Investors and their families gain permanent residency to live and work anywhere in the United States. One EB-5 investment allows the main applicant, spouse, and any unwed children under the age of 21 to all obtain Green Cards.*
- ❑ *Applying for EB-5 does not affect other ongoing forms of US legal status e.g. H1-B, F1, B1, etc.*
- ❑ *The first EB-5 immigration benefit comes in the form of a Conditional Green Card that you receive for two years from the time of application approval and investment made.*

FAQ's



Q: For whom was the EB-5 visa created?

Ans: The program allows for qualified Non-US citizens to seek permanent resident status on the basis of an investment in the US Economy.

Q: Is it worth it for me?

Ans: EB-5 is an immigration by investment program that requires you to make a minimum investment of \$800,000 to \$10,50,000 plus processing and admin fee. If you are on an existing non-immigrant visa in the US right now, you need to decide if the benefits of obtaining a Green Card is greater than renewing your non-immigrant visa every three years.

Q: What is the EB-5 visa priority date for India?

Ans: According to the US Department of State - Visa Bulletin August 2020, EB-5 priority date for India is Current. EB-5 investment visa I-526 processing time is estimated to range from 29 to 61 months. A temporary USA Green card is issued to the investor at the end of this process period. The Conditional Green Card is effective for 2 years.

Q: Will my investment be returned if my application is denied by the U.S. Citizenship & Immigration Services (USCIS)?

Ans: Yes, In the event that your I-526 application is denied, your investment will be returned to you minus administrative and legal expenses.

Q: What are the main reasons for denial of the EB-5 visa?

Ans: Producing false documents or the applicant failed to demonstrate that he/she has legally earned the investment capital. This may lead to delay and even denial.

Q: Do I have the money?

Ans: One of the most important aspects of the program is to show where the money for the investment is coming from. Whether it's your earnings, assets, or even gifts/loans from friends and family, you will need to be able to prove and show documentation for all sources of money in the investment.

Q: For how long is the "Green Card" valid?

Ans: The investor and the dependents receive a Conditional 2 -year Green Card. Upon the expiration of the 2-year period, a petition is submitted to the USCIS confirming that the investment has been made and that 10 jobs have been created as a result of the investment. Once approved the Green Card is valid permanently with no further action necessary.

Note: If the applicant is already in the U.S on another visa, it may not be necessary to return to the home country to obtain an EB-5 visa or permanent residence.



FAQ's



Q: Should I have any previous business experience?

Ans: No, it is not required.

Q: Can I apply for an EB-Visa if I have been previously denied a visa to the US?

Ans: Yes, if you have been previously denied a visa, you may still apply for an EB-visa.

Q: What are the other requirements to obtain EB-5 visa?

Ans: The applicant and any other accompanying family members must meet all requirements (eg; criminal, medical) stipulated by the immigration laws of the US.
